Crews Battle Wildfires In North & South Carolina Amid Dry Conditions, Winds

North and South Carolina on Sunday amid dry conditions and gusty winds as residents were forced to evacuate in some areas.

The National Weather Service warned of increased fire danger in the region due to a combination of critically dry fuels and very low relative humidity.

In South Carolina, where more than 175 fires burned 6.6 square miles (17 square kilometers), Gov. Henry McMaster declared a state of emergency on Sunday to support the wildfire response effort, and a statewide burning ban remained in

west of the coastal resort city of Myrtle Beach, where residents had been ordered to evacuate several neighborhoods, according to Horry County Fire Rescue. Video showed some people running down the street as smoke filled the sky. But by late Sunday afternoon, the fire department announced that Carolina Forest evacuees could return

The South Carolina Forestry Commission estimated Sunday evening that the blaze had burned 2.5 square miles (6.5 square kilometers) with 30 percent of it contained. No structures had succumbed to the blaze and no injuries morning, officials said.

In North Carolina, the U.S. Forest Service said fire crews were working to contain multiple wildfires burning in four forests across the state on Sunday. The largest, about 400 acres (162 hectares), was at Uwharrie National Forest, about 50 miles (80.47 kilometers) east of Charlotte. The Forest Service said Sunday afternoon that it had made progress on the fire, reaching about one-third containment.

The small southwestern town of Tryon in Polk County, North Carolina, urged some residents to evacuate Saturday as a fire spread rapidly there. The evacuations

That fire has burned about 500 acres (202 hectares) as of late Sunday, with zero percent containment, according to the Polk County Emergency Management/Fire Marshal's office. The North Carolina Forest Service was conducting water drops and back-burning operations on the ground, and area residents should expect a lot of smoke during those operations, officials said.

Officials have not said what caused any of the fires.

Hazel Dukes, the president of the New York State chapter of the NAACP and lifelong civil rights advocate, died Saturday at the age of 92.

Dukes peacefully passed away in her New York City home surrounded by amily, her son, Ronald Dukes, said in a statement.

Dukes, who led the New York State NAACP for nearly five decades. fought tirelessly for voting rights, economic development, fair housing and education through her career. Even in her 90s, she spoke out against police brutality and for adequate health care in underserved neighborhoods, the NAACP's New York State chapter said in a statement.

U.S. Allies Lash Out, Suggests Zelenskyy Should Resign

ald Trump's senior aides and allies lashed out at Ukrainian leader Volodymyr Zelenskyy from Washington as he attended a European summit Sunday in London to rally international support for his military's fight against the Russian invasion.

Following Trump's lead, White House officials and Republicans in Congress used news show appearances to demand that Zelenskyy display more gratitude for U.S. support and an openness to potential warending concessions to Russian President Vladimir Putin. Some suggested Zelenskyy should consider resigning even as Ukrainians rally around him.

But they offered little clarity as to what Zelenskyy and Ukraine could do after Friday's Oval Office meeting invaded in February 2022. in which Trump and Vice President JD Vance berated him before canceling the signature of an economic agreement between Washington and Kyiv. The dispute leaves the future of that relationship in question, as well as the prospects for ending a

HOUSE BILL WOULD ALLOW BETTORS TO DEDUCT LOSSES ON NC TAXES

North Carolina gamblers would be able to deduct losses on their state taxes under a bill the state House Commerce and Economic Development Committee discussed Tuesday.

North Carolina taxes winnings, but gamblers are not able to deduct their losses, bill sponsors said.

Rep. Keith Kidwell (R-Beaufort) is a gambling opponent who cosponsored

This is not a gambling bill," he said. "This is a fairness in taxation bill." The change would bring North Carolina in line with federal tax law, said

Rep. Erin Pare, (R-Wake). If a bettor won \$10,000 in a year but also lost \$10,000, the bettor would owe state income tax on the \$10,000 even though they just broke even, Pare said. The law leaves bettors with tax bills they may not be able to pay.

The bill would benefit people who bet big and itemize their deductions, Kidwell said.

Black Graves Are Being Moved To Make Way For An Industrial Park And It's Drawing A Mix Of Emotions

to move the remains of hundreds African American tenant farmers from a former Virginia tobacco plantation to a dedicated burial ground has elicited a range of emotions among the sharecroppers' descendants.

Some worry about the implications of disturbing the graves of people who were exploited and enslaved. Others hope the remains can be identified and reburied with more respect than they were afforded in

The mostly unidentified remains are being moved from a site that had been part of one of the nation's largest slave-owning operations, to make way for an industrial park.

When they were buried they weren't considered fully human, but now they are "patriots who are coming out of their graves with equal rights in 2025," one descendant, Cedric Hairston, said.

Archaeologists have already started exhuming the approximately 275 plots, and some of the remains of tenant farmers and their families are already in a funeral home but will be moved to the new burial site about a and white Hairston families. mile away. Officials have been consulting with descendants about genetic testing on unidentified remains as well as designs for the new cem-

great grandfather was buried at the plantation. "But for them to give us a lot of say so in the new cemetery, down to the design details and the plaques and memorials that we put up, I feel like (they're) really doing it in a dignified way, in a respectful way.'

African American cemeteries have suffered neglect, abandonment and destruction over the centuries. But efforts to preserve them are gaining momentum, with communities unearthingand rebuilding these crucial links to past generations.

While generally supportive of the project to move the graves, Hairston worries about the indignity of exhuming the graves of people who were brutalized as slaves and exploited as sharecroppers.

"It just seems that 100 or so odd years after their death, there's still no rest," he said.

Oak Hill was part of a family empire that enslaved thousands of people across 45 plantations and farms in four states, according to "The Hairstons," a 1999 book by Henry Wiencek that chronicles the Black

Samuel Hairston, the plantation's owner, was reputedly the largest enslaver in the South, Wiencek wrote.

But the grand property has stood etery, including a memorial archway. mostly empty and unused since "I don't think anybody would want their ancestors exhumed or moved," sharecropping ended last century. The 1820s plantation house was de-

Many who were enslaved at Oak Hill left after emancipation, Wiencek wrote. Those who remained as tenant farmers were often cheated of wages and faced crushing poverty and sometimes violence in the Jim

Some tenant farmers took the Hairston surname, in part because we had no other name to identify with, as the government was collecting data for the census. We brought no last name with us from Africa," Cedric Hairston said, adding, "Many Hairston child, never with the support of the law to report that they were raped."

One of the sharecroppers was Fleming Adams Sr., Bennett's great-Flem," he was born into slavery on another plantation in 1830. He later worked at Oak Hill, where he had to duck through doorways because he was so tall. Bennett said.

ICE AWARDS \$1B CONTRACT TO PRIVATE PRISON FIRM FOR MAJOR IMMIGRANT DETENTION CENTER

WASHINGTON - U.S. Immigration and Customs Enforcement has awarded a private prison company a 15-year contract worth \$1 billion to detain up to 1,000 immigrants in New Jersey, the first expansion of an immigrant detention center amid the Trump administration's plans for mass deportations.

"This detention center is the first to open under the new administration,"

ICE Acting Director Caleb Vitello said in a late Wednesday statement. "The location near an international airport streamlines logistics, and helps facilitate the timely processing of individuals in our custody as we pursue President (Donald) Trump's mandate to arrest, detain and remove illegal aliens On a Thursday earnings call, executives for one of the largest private pris-

ons, GEO Group Inc., told investors they expect "unprecedented opportunities" under the Trump administration's immigration crackdown by providing detention bed capacity and increasing electronic monitoring services of im-

The Newark detention center, Delaney Hall, will be the largest ICE processing facility and detention center on the East Coast, said George Zoley, the founder and executive chairman of GEO.

GEO has pushed for a contract with ICE to reopen that facility as a detention center and even sued New Jersey over its state law that bars private and public companies from contracting with ICE to detain immigrants..

Israel Blocks Aid Into Gaza As Standoff Escalates JERUSALEM/CAIRO, March 2 second phase was intended to see the

(Reuters) - Israel blocked the entry of aid trucks into Gaza on Sunday as a standoff over the truce that has halted fighting for the past six weeks escalated, with Hamas calling on Egyptian and Qatari mediators to

Israeli Prime Minister Benjamin Netanyahu's office said earlier that it had adopted a proposal by U.S. President Donald Trump's envoy, Steve Witkoff, for a temporary ceasefire in Gaza for the Ramadan and Passover periods, hours after the first phase of the previously agreed ceasefire ex-

If agreed, the truce would halt fighting until the end of the Ramadan fasting period around March 31 and the Jewish Passover holiday around April

The truce would be conditional on Hamas releasing half of the living and dead hostages on the first day, with the remainder released at the conclusion, if an agreement is reached on a permanent ceasefire.

Hamas says it is committed to the originally agreed ceasefire that had been scheduled to move into a second phase, with negotiations aimed at a permanent end to the war, and it has rejected the idea of a temporary extension to the 42-day truce.

A senior Hamas official, Mahmoud Mardawi, told Al Jazeera the group would only release the remaining Israeli hostages under the terms of the already agreed-upon phased deal.

Commenting on the goods suspension, senior Hamas official Sami Abu Zuhri told Reuters the decision would group "doesn't respond to pressures."

Later on Sunday, Israeli officials said a delegation would arrive in Cairo in an apparent move to discuss ways to defuse tensions and ensure the ceasefire remains in effect.

Jamaican Government Urged To 'Fully Decolonise' (Reuters) - Many Jamaicans want monarchy who believe the change ish colonies - it still retains the Brit-

> island of nearly 3 million people has been shifting for years, and in December the government of Prime Minister Andrew Holness presented a bill to remove King Charles.

Hundreds of thousands of enslaved Africans were shipped to Jamaica during transatlantic slavery, and many scholars and advocates say the legacy of slavery and colonialism has resulted in or played a role in enduring inequities. Growing calls by African and Caribbean nations for reparations to address past wrongs have added to a shift in sentiment across the region.

Britain has so far rejected calls for reparations. On the issue of removing the monarchy as head of state, Buckingham Palace usually says such matters are for the local people and politicians to decide. On a visit to the Bahamas in 2022, Prince William - who is now heir to the throne - said he supports and respects any decision Caribbean nations make about their future.

The Jamaican bill - which could be debated in parliament as early as this month or next - would have to be ratified in a referendum if passed. Before that, some critics - including the opposition People's National Party (PNP) - are raising objections to how a future president would be selected, what his or her role would be, and which court should be Jamaica's final court of appeal.

Steven Golding, head of the Universal Negro Improvement Association, founded more than a century ago by Jamaican civil rights leader Marcus Garvey, said the group and others had long advocated for the removal of "the last vestiges of the colonial umbilical cord".

But he added: "We must make sure that it's not a cosmetic surgery being done... we don't want to swap having a British monarch... to having a titular president. I would like to see an executive president, directly elected by the people.' Longstanding calls by some Ja-

maicans to abolish the monarchy picked up steam after Barbados, another former colony in the Caribbean, removed the late Queen Elizabeth as head of state in 2021. Holness told Prince William during a visit by the royal in 2022 that his country wanted to be "independent".

A survey by pollster Don Anderson in 2022 showed 56% of people in Jamaica wanted the monarch removed, up from 40% a decade ear-

According to the government's bill, Charles' representative in Jamaica - the governor general - would be replaced by a president nominated by the prime minister in consultation with the opposition leader.

Echoing DOGE, Republicans Begin To Probe NC Government Agencies

North Carolina legislature have begun summoning government leaders to answer a series of questions: What do you do? How do you do it? And how does it benefit the state?

The House Oversight Committee began its inquiries Thursday, hearing testimony from three new appointees of Gov. Josh Stein, two appointees of former Gov. Roy Cooper, and the state's newly elected Republican treasurer.

House Majority Leader Brendan Jones (R-Columbus), a chair for the committee, said it was the first in a "series of hearings" to evaluate if agencies are "effective and efficient."

"That's why we're here, to oversee, to ask what's working and what's not working," Jones said. "We want to know if North Carolinians are getting what they pay for."

The new scrutiny from state lawmakers echoes Elon Musk's "DOGE" office, which has over the past months sought to identify and cut swaths of the federal government. And though North Carolina lawmakers have not indicated that they want major cuts of their own, they have promised stricter oversight under a new governor's administration.

House Speaker Destin Hall (R-Caldwell) has formed a "government efficiency" committee of his own tasked with identifying "potential waste" and examining "excess" state property. That panel, distinct from the House Oversight Committee, has yet to formally meet.

And lawmakers overseeing hurricane recovery continue to probe ReBuild NC, the homebuilding program that has racked up a major deficit and struggled with mismanagement. Any money sent to the ongoing recovery efforts for Hurricane Helene will be closely tracked, law- want us to look at how to be more

makers have said.

Other Republican-led states have sought to mirror Musk's efforts in their own states. Iowa launched a task force earlier this month; Florida's committee will dive into university operations and spending.

"Everyone's excited about DOGE," said Rep. Brian Echevarria (R-

Multiple Democrats on the panel were more dubious.

"I don't know anyone that's excited about DOGE," responded Rep. Zack Hawkins (D-Durham). "Maybe him [Echevarria].

Rep. Amber Baker (D-Forsyth) said she would stay away from using "national terminology," and instead focus on the state specifically.

"I don't think anybody doesn't

efficient in things we do," Baker said. "I won't disrespect the people sitting here, to somehow imply you guys aren't doing all you can to be efficient.'

Among those topics probed by lawmakers Thursday was diversity, equity and inclusion programming within government.

DEI, which in the past has referred to hiring practices, internal training or specific programming, has emerged as a flashpoint for conservative criticism. President Donald Trump has called for the "elimination" of DEI across the federal government.

North Carolina Republicans are also taking aim at it — as multiple state departments take steps to distance themselves from the term.

After Echevarria read from the

statement, which included a section about "diversity and inclusion," the agency's director said it was from the previous administration and would 'not be included" in their new strate-

There were "DEI practices that were encouraged" from the state's HR office, director McKinley Wooten, Jr. said. The department did not have a specific DEI program, he added, and would be unaffected by legislation removing DEI from government.

Asked a similar question, budget director Kristin Walker said she had her team "strive to create a welcoming environment in our office.

"We absolutely do have to have the best and brightest."

Two newly elected Republicans have also pledged to get rid of any traces of DEI within their departments — State Treasurer Brad Briner and Auditor Dave Boliek.

Wooten, Briner and Walker all testified in front of the House panel Thursday. They were joined by State Controller Nels Rosland — a Cooper appointee, like Walker — as well as Joev Hopkins, the transportation secretary, and Wayne Goodwin, the soon-to-depart DMV commissioner.

The state's budget director also signaled Thursday that use of artificial intelligence could become more commonplace soon.

Asked whether artificial intelligence could play a role in detecting government waste, Walker said the state's Department of Information Technology was "soon going to allow state agencies access to Microsoft Copilot." Copilot is an AI tool used increasingly in workplace to automate some tasks — particularly connected to Microsoft's suite of other



Target Corporation's stock plummeted by approximately \$27.27 per share by the end of February, erasing about \$12.4 billion in market value. The drop came on February 28, the designated economic blackout day, and coincided with mounting backlash over the retailer's decision to abandon its diversity, equity, and inclusion (DEI) commitments.

The National Newspaper Publishers Association (NNPA) has taken action through its Public Education and Selective Buying Campaign. NNPA President and CEO Dr. Benjamin F. Chavis Jr. said, "Black consumers helped build Target into a retail giant, and now they are making their voices heard. If corporations believe they can roll back diversity commitments without consequence, they are mistaken."

Reverend Jamal Bryant, pastor of New Birth Missionary Baptist Church in Georgia, has led calls for a "40-Day Target Fast," urging Black consumers to withhold their spending at the retailer. "Black people spend \$12 million a day at Target," Bryant said. "If we withhold our dollars, we can make a statement that cannot be ignored."

The NAACP also issued a Black Consumer Advisory in response to Target's DEI rollback, warning Black consumers about corporate retreat from diversity initiatives. The advisory urges them to support businesses that remain committed to investing in Black communities.

Target is also facing legal battles. Shareholders have filed lawsuits challenging the company's DEI policies, arguing that the commitments hurt financial performance. Meanwhile, conservative groups have sued over Target's diversity efforts, claiming they discriminated against white employees and other groups.

"Consumers have the power to demand change, and Target is learning that lesson the hard way," Chavis said.
